Subject: AMENDED RESPONSE TO HEMATITE DECOMMISSIONING PROJECT

The U.S. Nuclear Regulatory Commission (NRC) has received your letter dated August 31, 2016, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16252A270), in regards to Westinghouse Electric Company, LLC's (Westinghouse) Hematite Decommissioning Project. Your August 31, 2016, letter requested the withdrawal of the comments and objections that you made in your March 5, 2015, letter (ADAMS Accession No. ML15069A039) regarding Westinghouse's "Request for Review of Approach for Unrestricted Release of Soil in the Vicinity of the Former Evaporation Ponds that Structurally Support an 8-Inch Diameter High Pressure Natural Gas Pipeline at the Hematite Decommissioning Project." Specifically, your March 5, 2015, letter expressed concerns that Westinghouse's proposal to leave in place contaminated soil beneath your natural gas pipeline at the Hematite, Missouri plant may expose your workers to radiological and chemical hazards. As indicated in your August 31st letter, the concerns identified in your March 5, 2015, letter have been resolved.

By separate letter, we will inform Missouri Department of Natural Resources (MDNR) of your correspondence on this issue. Per your request, the NRC will consider the comments and objections set forth in your March 5, 2015, letter as being withdrawn and will otherwise consider the issue identified in your March 5, 2015, letter as being resolved. The NRC will take no further action on this matter, unless the MDNR informs the NRC that it still wishes to pursue this issue.
