Subject: Request for Additional Information; Change of Control

Discussion: Mr. Adams was contacted to request additional information in order to support a basis for confidence that the material would be used as proposed on the licenses. This is a change of control for two licenses, CONSOL of Kentucky, Inc., and Fola Coal Company, LLC, are being purchased in an asset purchase by Southeastern Land, LLC. Mr. Adams is the Attorney in Fact for Southeastern Land, LLC. I asked Mr. Adams if Southeastern Land maintained any other radioactive material licenses. Mr. Adams responded that they do not directly control any additional licenses; however, the principals of Southeastern Land also are partners or wholly own other companies that do have radioactive materials licenses. I asked Mr. Adams to describe the relationship between the owners of Southeastern Land and the sister companies and to provide information about the radioactive materials licenses those sister companies maintain. Mr. Adams said he would provide that information in a letter. He also stated that it may take a day or two to acquire the information and respond.
