Dear Mr. Holtz:

By the letter dated June 30, 2016, The Waterbury Hospital requested written consent by the U.S. Nuclear Regulatory Commission (NRC) to a proposed direct transfer of control of NRC Materials License No. 06-02406-01 (ADAMS Accession Number ML16193A035). Based on the information you provided, we understand that as a result of the sale of substantially all of the assets of The Waterbury Hospital's parent company, Greater Waterbury Health Network, Inc., to Prospect Medical Holdings, Inc., control of The Waterbury Hospital will be directly transferred to Prospect Medical Holdings, Inc., which will become a parent company to a new entity named Prospect Waterbury, Inc. d/b/a The Waterbury Hospital. We understand that this transfer will not result in any change to the location of use, materials, persons using licensed material, or persons responsible for radiation safety at the licensed facility.

Based on the above understandings, as more fully detailed in the enclosed Safety Evaluation Report, which documents the NRC staff's safety review of the request, and in accordance with 10 CFR § 35.18, the NRC approves the proposed transfer. An environmental assessment for this action has not been prepared by the NRC, because this action is categorically excluded under 10 CFR 51.22(c)(21). Please find enclosed Amendment No. 72 authorizing the licensee name change to Prospect Waterbury, Inc. d/b/a The Waterbury Hospital. We understand that the transfer will take place on October 1, 2016. The amended license will become effective on the date of transfer, but no later than 30 days after the date of this approval letter. Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the sales agreement confirming completion of the transaction. If this planned sale has not been consummated within 30 days of the date of this letter, please notify us in writing. Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions of the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material require submission of a request to amend the license. NRC approval must be received prior to implementation of the proposed change.

You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a notice of violation, imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the NRC Enforcement Policy.
