This refers to your license amendment request dated July 12, 2016. Please find enclosed Amendment No. 18 which removes authorization for sulfur 35, chromium 51, and iodine 125. This amendment does not remove the facility located at 352 Knotter Drive, Cheshire Connecticut as you had requested. You were unable to provide the requested information as stated in our electronic mail dated July 25, 2016, in a timely manner, as discussed in a telephone call with Mr. Paradiso on October 3, 2016. Please submit the information when available to remove your facility.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
