This refers to your license amendment request dated August 29, 2016. Please find enclosed Amendment No. 13 authorizing a change in the Radiation Safety Officer and removing the Plant #3, Street C, Lot #39, Urb. Industrial Luchetti location from your license. You may release this facility for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).
