Thank you for your September 23, 2016, letter advocating U.S. Nuclear Regulatory Commission (NRC) acknowledgement of the special status that Native Hawaiian organizations (NHO) are provided by the National Historic Preservation Act (NHPA) and specifically within the NHPA Section 106 regulations. In addition, the letter stated that the Advisory Council of Historic Preservation urge NRC to consider developing a policy statement or guidance that acknowledges this role and the importance of strengthening your consultative relationship with NHOs.

The NRC Tribal Policy Statement and Tribal Protocol Manual pertain to consultation with Tribal governments recognized by the Federally Recognized Indian Tribe List Act of 1994, 25 U.S.C. 479a. The United States has recognized and implemented a special political and trust relationship with the Native Hawaiian community through programs and services that are, in many respects, analogous to, but separate from the programs and services enacted for Federally recognized Indian Tribes. However, Native Hawaiian Organizations are not governmental entities. As a result, Native Hawaiian Organizations are not covered by the NRC Tribal Policy Statement. The NRC does comply with statutory obligations to consult with Native Hawaiian Organizations. For example, the NRC consults with Native Hawaiian Organizations, as appropriate, under Section 106 of the NHPA.
