- SUBJECT: SUMMARY OF THE SEPTEMBER 19, 2016, PUBLIC TELECONFERENCE MEETING WITH KOREA HYDRO AND NUCLEAR POWER CO. LTD. TO DISCUSS TOPICS RELATED TO ADVANCED POWER REACTOR 1400 DESIGN
