SUBJECT: SUMMARY OF SEPTEMBER 29, 2016, PARTIALLY CLOSED

TELECONFERENCE WITH WASTE CONTROL SPECIALISTS (WCS)

TO DISCUSS THE DRAFT REQUEST FOR SUPPLEMENTAL INFORMATION AND OBSERVATION RESPONSES FOR ITS CONSOLIDATED INTERIM STORAGE FACILITY LICENSE

APPLICATION (TAC NO. L25112)

PURPOSE:

For the Nuclear Regulatory Commission (NRC) staff and WCS representatives to discuss the draft request for supplemental information (RSI) and observation responses for its Consolidated Interim Storage Facility (CISF) license application.

MEETING SUMMARY:

On September 29, 2016, NRC staff held a partially closed teleconference with representatives from WCS. Attendees included WCS and its contractors, NRC staff, and members of the public. The list of meeting attendees is in Enclosure 1. The discussion followed the agenda provided in Enclosure 2. The NRC also provided comments on several RSI responses that WCS submitted on August 31, 2016. WCS provided meeting slides prior to the meeting. The meeting slides can be found using Agencywide Documents Access and Management System (ADAMS) Accession No.r ML16272A108.

In the public portion of the meeting, after introductions and opening remarks, representatives from WCS discussed the draft RSI and observation responses WCS planned to submit on September 30, 2016. During the presentation, WCS provided an overview of the draft response for each of the RSI and observation before soliciting comments from the NRC staff. The NRC commented on non-proprietary observations 1.3, 2.1, 12.1, 14.1 and informed WCS the staff had no comments on non-proprietary RSI 4.2 due to limited review time. WCS concluded the presentation by stating the staff's comments would be incorporated into its response submittals. In addition, the WCS submittal planned for September 30, 2016, would describe an approach to the remaining commitments. WCS also committed to proposing, when necessary, schedule adjustments to ensure high quality, accuracy and completeness in all submittals.
