SUBJECT: INSPECTION REPORT NOS. 50-269/87-02, 50-270/87-02, AND 50-287/87-02

As a result of an inspection conducted at your Oconee Nuclear Station which reviewed fire protection of the alternate shutdown capability, a Notice of Violation (NOV) was sent to Duke Power Company (DPC) by letter dated May 5, 1987. In your June 4, 1987 response to this letter, DPC admitted the violation but requested that the Severity Level be reduced from III to IV. By a letter dated December 17, 1987, the NRC/Region II declined to reduce the Severity Level of the NOV on the basis that sufficient justification was not provided to substantiate DPC's design basis assumption for the standby shutdown facility for no spurious valve actuation occurring during the first ten minutes following a fire. In your April 20, 1988 letter, you provided further clarification on this issue and requested Region II resolve the inconsistency between the December 17, 1987 letter and the NRC Safety Evaluation Report (SER) issued April 23, 1983.

Based on the clarifications provided by DPC in the April 20, 1988 letter, and the results of an in-depth Office of Nuclear Reactor Regulation (NRR) review of this issue, we have confirmed that the previous tacit acceptance of a ten-minute delay in postulation of spurious signals in the NRC SER of April 23, 1983, is still valid. Therefore, we have concluded, based on this additional information that sufficient justification exists that the Severity Level of the violation be reduced from Level III to Level IV. Our records will be adjusted accordingly. During this review, however, additional issues have been raised by the staff which will be addressed in separate correspondence.


We understand that corrective actions identified in your June 4, 1987 response are in place to remedy any potential problems which, in the event of fire, may affect primary system integrity due to spurious valve actuations.
