Subject: LaSalle County Station Physical Security Plan (Revision 15)

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting Revision 15 to the LaSalle County Station (LSCS) Physical Security Plan. The change to the LSCS Physical Security Plan was implemented on September 19, 2016. In accordance with 10 CFR 50.54(p)(2), EGC is submitting this change within 60 days of implementation (i.e., no later than November 18, 2016).

The LSCS Physical Security Plan has been revised to incorporate Handgun Elimination. Details of these changes are attached and classified as safeguards information. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (a)(1)(i), and 10 CFR 73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(1)(i).

EGC has concluded that the changes do not decrease the safeguards effectiveness of the LSCS Physical Security Plan.

There are no regulatory commitments made within this letter.
