Question 1

Confluence Life Sciences, Inc. is the current holder of the NRC license and Confluence Discovery Technologies, Inc. is a wholly owned subsidiary to which the NRC license will transfer. A single Board of Directors and Management Team is in place with responsibilities for both entities and this organizational structure will remain intact. No planned change in Directors, stock asset changes, mergers etc. are associated with this transfer of control of the license.

Question 2

There will be no changes in personnel or duties that are related to the license.

Question 3

There will be no changes in the location, facilities, equipment, radiation safety program, use, possession, waste management or other procedures that relate to the licensed program.

Question 4

The licensee's facility and equipment are free of any known contamination. It will not be necessary to perform decontamination for the transfer. Furthermore, the facility and equipment will not change upon transfer of license to Confluence Discovery Technologies. The radiation safety program, instrument calibration, area surveys, wipe tests, training, quality control and all records are current and up to date.

Question 5

This transfer is specifically associated with the shift in control from the parent organization, Confluence Life Sciences, Inc. to its wholly owned subsidiary, Confluence Discovery Technologies, Inc. No change in facilities or organizational structure is associated with this change in control. As the facilities in which the radiation work is being performed has not changed there is no need for decommissioning the laboratory therefore Decommissioning Funding Plans are not applicable.

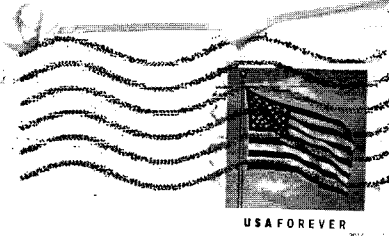
