Enclosed is Amendment No. 50 to your NRC Materials License No. 34-29200-01MD, in accordance with your requests in letters dated June 10, 2016 and July 21, 2016.

Please also find enclosed Amendment No. 49 (Corrected Copy). It came to our attention that the Amendment No. 48 was inadvertently duplicated with the amendment issued on August 18, 2016. There were also errors associated with the wording in Item 8 regarding the possession of licensed material at all facilities listed in Condition 10 of your license. This error has been corrected. We apologize for any inconvenience these errors may have caused you.

As part of your request in letter dated June 10, 2016, you provided survey information to show that a storage area within the former restricted area at 9668 Marion Ridge, Kansas City, Missouri, had no residual activity above NRC limits. We have reviewed this information and have concluded that all licensable radioactive material has been removed from the storage area of your facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, you may release this area for unrestricted use.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
