A clarification telephone call was held today at 1500 EDT regarding the October 19, 2016, request for additional information (RAI) (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16293A901). The RAIs were in response to the June 30, 2016, license amendment request (ADAMS Accession No. ML16193A656).

During the clarification call, a change was suggested to question 1.a to add the statement "for a period of 48 hours". After the clarification call, a member of the Duke Energy staff called me and stated that the change wasn't necessary, so no changes will be made to the RAI questions.

Also during this second call, a revised due date of December 8, 2016, for the RAI response was proposed. The NRC staff finds the extension acceptable and will be expecting to receive the RAI responses by December 8, 2016.
