This refers to your letter 15-148, dated November 30, 2015, which submitted an updated Decommissioning Funding Plan in a revision to Chapter 10 of the License Application in accordance with Title 10 of the *Code of Federal Regulation* (10 CFR) Paragraph 70.25(e). In addition, BWXT NOG, Inc. replied to a Request for Additional Information (RAI) with attachments contained in your letter 16-048 dated July 14, 2016.

The U.S. Nuclear Regulatory Commission (NRC) has completed its review of the plan, and it was found to be acceptable. A Safety Evaluation Report is enclosed.
