Dear Rulemakings and Adjudications Staff:

At this time, the U.S. Nuclear Regulatory Commission is considering the approval of the application filed by Entergy Nuclear Operations, Inc. (ENO) and Exelon Generation Company, LLC (Exelon) which seeks the Commission's approval of the transfer of James A. Fitzpatrick Nuclear Power Plant from the current holder, ENO, to Exelon.

As one of the members of Assembly representing Oswego County, I support this transfer of ownership which is critical to keeping FitzPatrick in operation. The plant provides hundreds of high-paying, skilled jobs in Oswego County and the Central New York region. In addition, the transfer is vital to meeting the state's 2030 goal to reduce greenhouse gas emissions by 40 percent, ensuring a reliable supply of non-carbon emitting electrical power.

Again, I express my support of this application and I urge the Commission's timely approval of the transfer of control of FitzPatrick from Entergy Nuclear Operations, Inc. to Exelon Generation Company.
