Dear Ms. Bladey:

The U.S. Environmental Protection Agency has reviewed the Final Supplemental Environmental Impact Statement (EIS) for the above-mentioned project prepared by the U.S. Nuclear Regulatory Commission (NRC). Our comments are provided pursuant to the National Environmental Policy Act (NEPA), the Council on Environmental Quality's NEPA Implementing Regulations (40 CFR 1500-1508), and Section 309 of the Clean Air Act.

LaSalle County Station (LSCS) is a two-unit, nuclear powered steam-electric generating facility operated by Exelon Generation Company, LLC. LSCS is approximately 82 miles southwest of Chicago, Illinois. The surrounding area is primarily rural and agricultural. The applicant applied to the NRC to extend LSCS's operating license for an additional 20 years. No refurbishment activities associated with the license renewal are proposed. NRC's preferred alternative is to grant the license renewal.


EPA reviewed the Draft Supplemental EIS and provided comments in a letter dated April 4, 2016. Our comments focused on clarification to potential impacts to surface water and climate change methodology as a result of continued operation.

EPA has no further comments on the Final SEIS. We found NRC's response to comments to be adequate.
