Dear Mr. Teahon:

By letter dated September 21, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15310A373), Crow Butte Resources, Inc. (CBR) requested an exemption to 10 CFR 20.1204(g)(1). Specifically, CBR requested that it not be required to use the total beta activity of radionuclide mixtures in air when demonstrating compliance with the dose limits in 10 CFR 20.1201.

Please see attached draft license condition (LC) 10.8 addressing this request.

In addition, the NRC is removing or modifying license conditions that CBR has addressed as required in its renewed license issued on November 5, 2014 (ADAMS Accession No. ML13324A101). These include LC 10.12, LC 11.11, and LC 11.13 to LC 11.16. LC 9.2 was revised to incorporate commitments that address the conditions noted above.

Attached for your review is the proposed draft Amendment No. 1 to Materials License SUA-1534. Please let me know at your earliest convenience if the language is acceptable.
