This refers to your license amendment request dated August 9, 2016. Please find enclosed Amendment No. 17 which removes Building 45 from your licensing basis. Building 45 may be released for unrestricted release.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).
