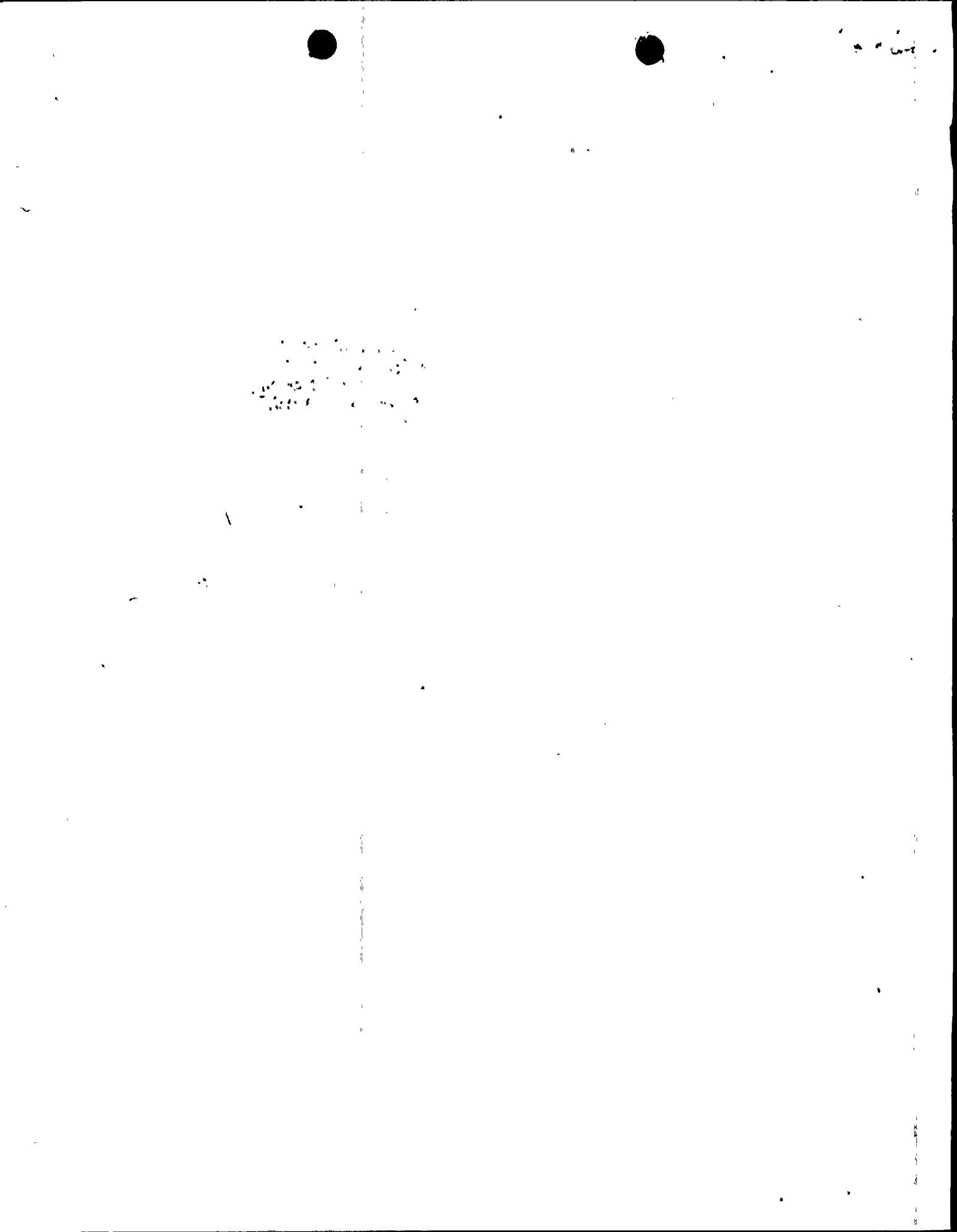
I am pleased to respond to your letter of April 27, 1977 in which you requested additional information concerning the Commission's safety reviews of the North Anna Nuclear Power Station in Virginia and the Diablo Canyon Power Plant in California.

As discussed with your staff, the majority of the internal documents you requested have been publicly released and are available for inspection at the NRC Public Document Room (PDR) at 1717 H Street, N. W., Washington, D. C. 20555. The PDR also contains copies of seismic related documents for the Diablo Canyon Power Plant provided in response to three Freedom of Information Act (FOIA) requests. These documents are filed under FOIA 76-411, FOIA 77-48 and FOIA 77-60. The staff response to FOIA 77-48 did not include portions of three documents and seven other documents in their entirety which were withheld from public release pursuant to exemption (5) of the FOIA. In particular, the withheld documents included a document covered by the attorney work product privilege. Although we are pleased to provide these documents, we request that they be given appropriate confidential treatment; a treatment which has been given to other NRC documents in similar circumstances by other Congressional Committees. Copies of these documents are included as Enclosure 1.

A search of the staff's files located other internal documents subject to your request and copies are provided as Enclosures 2, 3, and 4 to this letter.

Your request for a copy of the Office of Inspector and Auditor's report into the allegations of misconduct of NRC inspectors at the North Anna plant will be responded to pursuant to your request in your letter to me dated April 29, 1977. As you may know, a criminal investigation is underway regarding the North Anna Nuclear Power Station.
