MOTION OF PACIFIC GAS AND ELECTRIC COMPANY  
FOR EXTENSION OF TIME TO ANSWER INTERROGATORIES

On October 16, 1974 PGandE received a set of 41 inter-rogatories from the San Luis Obispo Mothers for Peace dated October 14, 1974. Under the regulations (10 CFR 2.740b) PGandE's responses to these interrogatories should be mailed October 31, 1974.

The interrogatories are extensive and the time specified in the regulations within which to file answers is insufficient. Persons qualified to gather the material for the responses are also engaged full time in the continuing work of completing the design and construction of the Diablo Canyon units and preparing for their operation. Counsel for the Company who must review the answers to interrogatories has been engaged in answering various motions filed by the San Luis Obispo Mothers for Peace in this same proceeding as well as filing a brief in opposition to exceptions filed by the AEC Staff in the Unit 2 NEPA proceeding.




In addition, said counsel must be out of the office on a business trip October 28 through October 31, 1974.


