The purpose of this meeting was for the NRC staff and the PWROG representatives to discuss performance monitoring requirements for pump seal and the applicability of the requirements to the Generation III Westinghouse Shutdown Seal.

During the open portion of the meeting, the NRC staff indicated the desire to have the Generation III Westinghouse Shutdown Seal under a form of performance monitoring program. The PWROG representatives indicated that performance monitoring is not applicable to the PRA model, for which the TR is requesting approval. The PWROG believes that performance monitoring is associated with a change to the licensing basis. During the closed portion of the meeting, both the NRC staff and the PWROG representatives gave presentations to support the positions taken.
