Such appointment must become effective prior to February 7, 2017. If Grantor fails to provide the Trustee with a written notice instructing the Trustee to pay over all funds held in the standby trust fund to the successor Trustee prior to the close of business on February 7, 2017, then as provided for in Section 13 of the Trust Agreement, the Trustee may apply to a court of competent jurisdiction for the appointment of a successor trustee or for instruction.
