SUBJECT: ARKANSAS NUCLEAR ONE, UNIT 1 - REQUEST FOR WITHHOLDING  
INFORMATION FROM PUBLIC DISCLOSURE (CAC NO. MF4201)

Dear Sir or Madam:

By letter dated May 24, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16147A321), Entergy Operations, Inc. (Entergy, the licensee) submitted an affidavit executed by Morris Byram, AREVA Inc. (AREVA), dated May 6, 2016, requesting that information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

ANP-3417P, Revision 1, "MRP-227-A Applicant/Licensee Action Item #7 Analysis for Arkansas Nuclear One Unit 1," dated May 2016

The information is included in Attachment 1 to Entergy's letter dated May 24, 2016. A nonproprietary version of ANP-3417P, Revision 1, designated as Attachment 2 to Entergy's letter dated May 24, 2016, has been placed in the U.S. Nuclear Regulatory Commission's (NRC's) Public Document Room and added to ADAMS in the NRC Library at Accession No. ML16147A324.

The affidavit stated that the information sought to be withheld is considered to be proprietary for the reasons below:

- b. Use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- c. The information includes test data or analytical techniques concerning a process, methodology, or component, the application of which results in a competitive advantage for AREVA.
- d. The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA in product optimization or marketability.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavits, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.


Therefore, the versions of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
