NRC Enforcement Policy: Policy Revision; Issuance; Chapter 1 of Title 10 of the Code of Federal Regulations (10 CFR) (NRC-2014-0221)

On November 7, 2016, the NRC issued a revision to its Enforcement Policy ([81 FR 78022](#)) to incorporate changes approved by the Commission. The revision incorporates lessons learned along with miscellaneous clarifications and additions. The NRC provided an opportunity for the public to comment on these policy revisions in a document published in the *Federal Register* on October 9, 2014 ([79 FR 61107](#)). This revision is effective on November 7, 2016.

List of Approved Spent Fuel Storage Casks: Holtec International HI-STORM Flood/Wind Multipurpose Canister Storage System, Amendment No. 2; Direct Final Rule; Confirmation of Effective Date; 10 CFR Part 72; (Regulation Identifier Number (RIN) 3150-AJ75; NRC-2016-0103)

On November 7, 2016, the NRC published a document in the *Federal Register* ([81 FR 78021](#)) confirming the effective date of November 7, 2016, for the direct final rule that was published in the *Federal Register* on August 23, 2016. The direct final rule amended the NRC's spent fuel storage regulations by revising the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 2 to Certificate of Compliance No. 1032 for the Holtec International HI-STORM Flood/Wind Multipurpose Canister Storage System.

Role of Third Parties in Access Authorization and Fitness-for-Duty Determinations: Proposed Rule; Public Meeting; 10 CFR Part 73 (RIN 3150-AJ79; NRC-2016-0145)

On November 7, 2016, the NRC published a document in the *Federal Register* ([81 FR 78062](#)) announcing plans to hold a public meeting to discuss a rulemaking activity regarding the role of third parties in access authorization and fitness-for-duty determinations. The purpose of the meeting is to provide information on the background and status of this rulemaking activity and to obtain input from interested stakeholders. The public meeting will be held on November 16, 2016, from 1:00 p.m. to 4:00 p.m. eastern standard time. Individual Monitoring Devices for Industrial Radiographic Personnel: Petition for Rulemaking; Notice of Docketing and Request for Comment; 10 CFR Part 34 (NRC-2016-0182)

On November 9, 2016, the NRC published a notice of docketing in the *Federal Register* ([81 FR 78732](#)) for a petition for rulemaking (PRM) dated July 14, 2016, from Dr. Army Bereson of the Nondestructive Testing Management Association and Mr. Walt Cofer of the American Society for Nondestructive Testing. The petitioners request that the NRC amend its regulations to authorize use of improved individual monitoring devices for industrial radiographic personnel. The PRM was docketed by the NRC on August 12, 2016, and has been assigned Docket Number PRM-34-7. The NRC is examining the issues raised in PRM-34-7 to determine whether they should be considered in rulemaking. Comments on PRM-34-7 are due by January 23, 2017.
