Technical Exchange Meeting with the Japanese Nuclear Regulation Authority (NRA)

During the week of November 14, 2016, staff from RES, with substantial support from the Office of Nuclear Reactor Regulation, Office of New Reactors, and Office of International Programs, conducted a four-day technical exchange meeting with representatives from the Japanese Nuclear Regulation Authority (NRA). The five member NRA delegation included experts in probabilistic risk assessment (PRA) and severe accident modeling. The meeting included discussions on many topics of mutual interest, including general PRA modeling, severe accident analysis and mitigation, and risk-informed regulatory applications (e.g., the significance determination process). The information exchange will help both NRA and the NRC leverage international PRA research and experience to benefit ongoing risk-informed initiatives associated with operating reactor oversight and licensing programs.
