NONCONFORMANCE

Dear Mr. Stack:

Thank you for your letter dated September 6, 2016, in response to the Notice of Nonconformance (NON) that was discussed in the subject U.S. Nuclear Regulatory Commission (NRC) Inspection Report.

We have reviewed your letter and found that is not fully responsive in addressing NON 99901470/2016-202-01. Your response for NON 99901470/2016-202-01 states that "Until suppliers are approved for Method 2, material (and dimensional inspections) will follow the CGD Method 1 with enhanced EPRI sample size requirements." However, it is still not clear that Namco has established an engineering evaluation for the interim sampling plans chosen to verify material and dimensional critical characteristics.

Please provide a response within 30 days of this letter that explains your rationale for the use of the enhanced EPRI sampling plan. The agency will consider extending the response time if you show good cause for us to do so.

If you request that such material is withheld from public disclosure, you must specifically identify the portions of your response that you seek to have withheld and provide in detail the bases for your claim (e.g., explain why the disclosure of information will create an unwarranted invasion of personal privacy or provide the information required by 10 CFR 2.390(b) to support a request for withholding confidential commercial or

financial information). If safeguards information is necessary to provide an acceptable response, please provide the level of protection described in 10 CFR 73.21 "Protection of Safeguards Information: Performance Requirements."
