Revisions to Transportation Safety Requirements and Compatibility with International Atomic Energy Agency Transportation Standards: Notice of Issues Paper, Public Meeting, and Request for Comment; Part 71 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ85; NRC-2016-0179)
