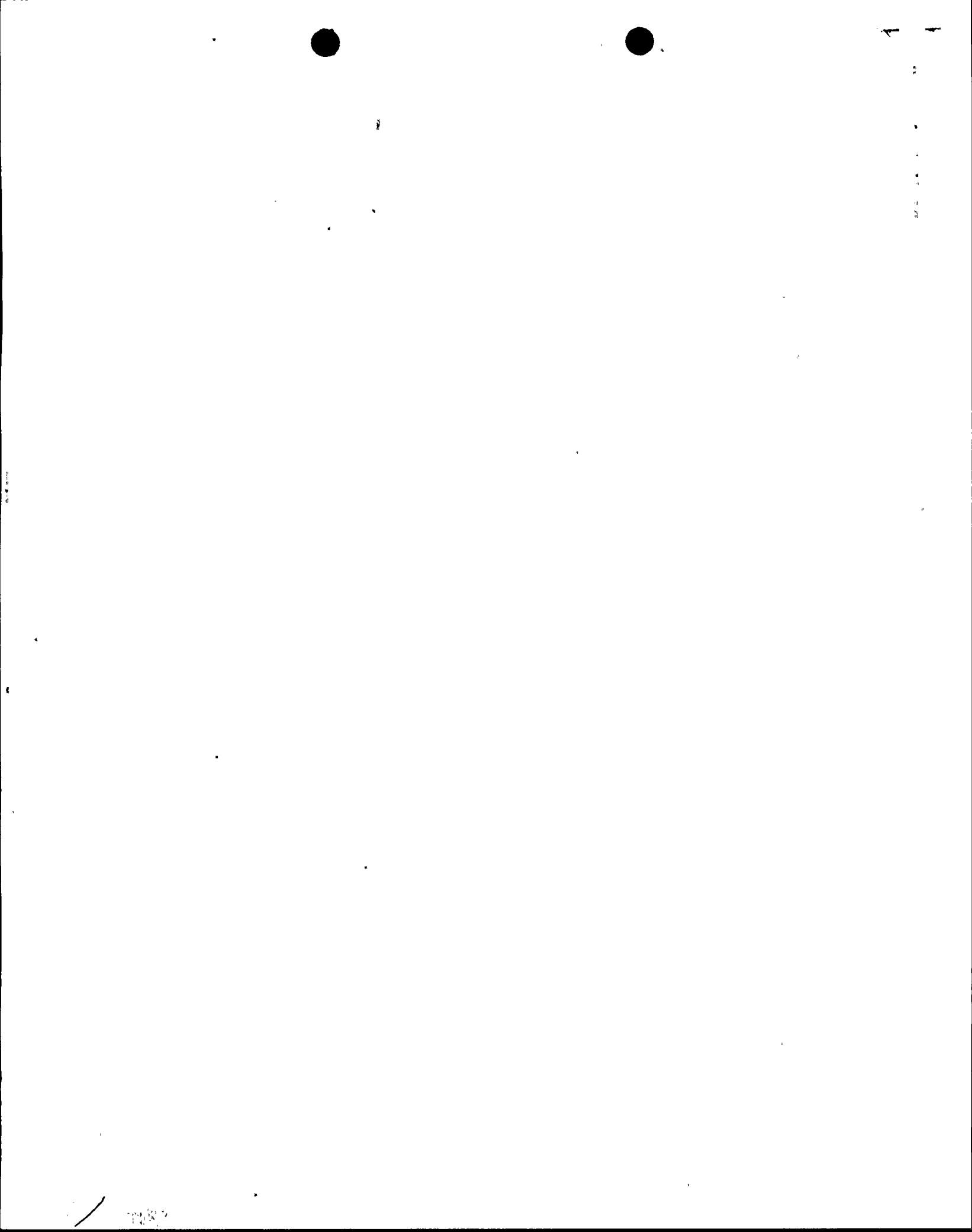
DEAR REPRESENTATIVE PANETTA:
