



This preliminary report is made pursuant to 10 CFR 50.55(c). The report concerns a possible defect in equipment installed at the Diablo Canyon Site, Unit 1, which could adversely affect plant safety. This concern was reported verbally to the Region V office on January 18, 1980.

Plastic castings used to hold auxiliary electrical contacts in safety related 4 kV circuit breakers at Diablo Canyon Unit 1 (a different switch design has been installed in Unit 2) had been observed to contain cracks. If the cracking continued to the point of failure, movable contacts of the circuit breaker auxiliary switch could become dislodged and render the switch inoperative. This mode of failure would prevent operation of the 4 kV breaker mechanism and preclude its safety function. It should be noted that these breakers have been exercised repeatedly in preoperational tests and no failure has occurred.

The equipment is the auxiliary switch component of General Electric Vertical Lift Metal Clad Switchgear with Magna-blast power circuit breakers, rated 4160 volt, 250 MVA. The auxiliary switch is the basic switch mechanism from the GE SBM type control switch. The NRC Staff was informed of this problem by the General Electric Company in a memo issued by its I.& S.E. group in 1976.

Discussions are presently being conducted with GE to resolve the issue. It is anticipated that the switch mechanism will

be replaced with a mechanism having a design which is not subject to this problem. The replacement will be made before power operation.

A final report will be submitted when resolution has been reached with GE.
