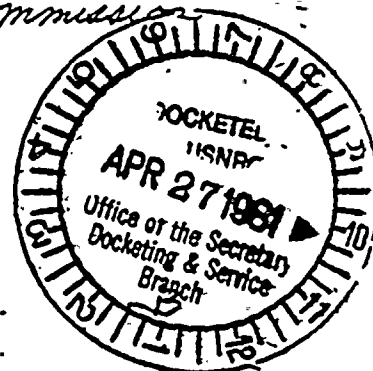

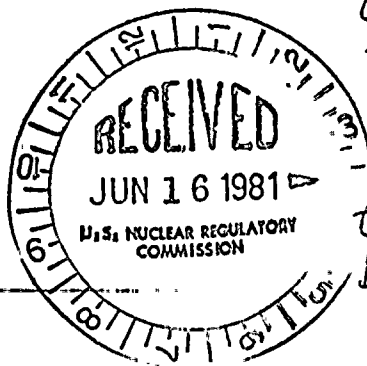
Dear Mr. Hendrie,

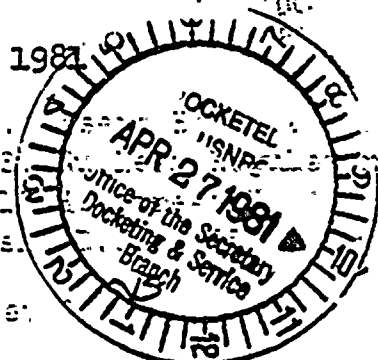

Dear Sir:

I am a resident of San Luis Obispo County and am concerned about the safety and survival of the Central Coast of Calif.

The Hosgri Fault still lies less than three miles from the plant and evacuation plans are inadequate.

Plant security is being kept a secret from the public by PG & E.

A means of storing and disposing of the radioactive toxic waste which will be produced by an operating Diablo Canyon nuclear plant has not been developed.

In 25-30 years the plant will have to be decommissioned. Will PG & E spend the millions to decommission or will the plant sit on our coast deteriorating indefinitely as the Three Mile Island plant in Penn. and the Humboldt Bay plant in Eureka now are doing?

I urge you to call for another set of public hearings and thank you for any effort on your part.

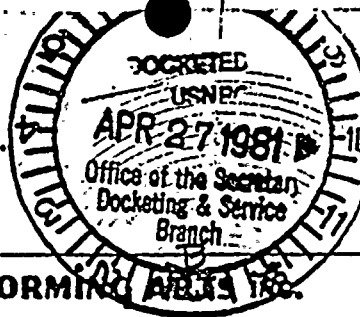

Mr. Hendrie and Commissioners:

It has recently come to my attention that Pacific Gas and Electric Co. has asked the Commission to waive further hearings on it's proposed Diablo Canyon Nuclear Power Station.

I would caution you to not accept this bid for low power nuclear tests due to the potential risks to the health and safety of the citizens and workers. (It would appear that the Santa Maria Chamber of Commerce disregards worker and citizen health and safety according to their recent resolution, although my testimony was well received by the Santa Maria City Council, opposing the license).

Yet to be decided, as you know are issues of an earthquake fault near the Diablo site, a possible tributary splay of an earthquake fault lying directly adjacent to the north side of the facility, Emergency Planning Documents, which should be in effect previous to any further operations of the facility, plant security, an inundated and poorly designed breakwater at the site, De-commissioning, which is currently being studied by the State of California and a few more issues which pertain to NEW INFORMATION regarding P.G. & E's ability to safely and legally conduct business.

I have asked the Public Utilities Commission of California to investigate the utility because of alleged illegal diversion of rate-payer's funds to shareholders interests, faulty metering of electric use by customers, and harrassment of the public (50%) locally, who oppose the utility's nuclear plant.

Also, questions should be raised about the ability of PG&E to operate such a tricky type of technology. Is'nt it true that PG&E's only other nuke, the Humboldt reactor in California was permanently closed due to radiation leakage, and was there not evidence that the utility had attempted to tamper with evidence before that counties Grand Jury? If in part, these allegations are true, then there should be no question that there should be no license for Diablo Canyon to be operated by this company.

I urge continued hearings and unless some method is shown proving that no harm can come to citizens or workers the license should be denied and the plant converted to natural gas driven electric turbine, or solar energy.

I look forward to your response.
