Miccosukee Tribe of Indians of Florida

- Chairman - Billy Cypress (POB 440021, Tamiami Station, Miami, Fl. 33144, Ph. 305-223-8380)
- Tribal Historic Preservation Officer – Miccosukee Tribe does not have a THPO

Seminole Tribe of Florida (Dania, Big Cypress, Brighton, Hollywood and Tampa Reservations)

- Chairman – Marcellus Osceola (James E. Billie would have been the Chairman during much of the review of the COLA/EIS, he was replaced about a month ago.) (6300 Stirling Road, Hollywood, Fl. 33024, Ph. 800-683-7800)
- Tribal Historic Preservation Officer – Paul Backhouse (30290 Josie Billie Hwy, Clewiston, Fl. 33440, Ph. 863-983-6549, Ext 12244)

Florida does not have a process to officially recognize tribes.
