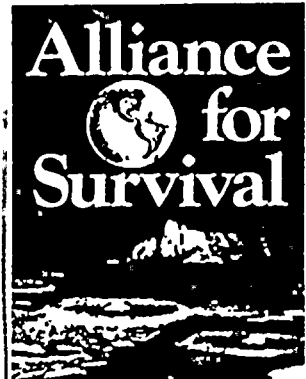

VALENTINE DAY OBSERVANCE OPPOSES DIABLO CANYON NUCLEAR REACTOR  
- DIABLO PROTESTER ENDS HUNGER STRIKE AT VALENTINE CEREMONY

"No broken hearts; no split atoms" will be the theme of a public Valentine/anti-nuclear tree-decorating ceremony as well as the culmination of a successful one-month hunger strike, both opposing licensing of Diablo Canyon nuclear power plant. This fifth annual Alliance for Survival Valentine observance will take place from noon till 1 PM, Tuesday, Feb. 14 by The Children's Tree of Life located at Ocean Ave. and Colorado St. in the southernmost end of Santa Monica Palisades Park.

Santa Monica City Councilman JAMES CONN will speak and recording artist STEPHEN LONGFELLOW FISKE will perform as Diablo opponents appropriately decorate the tree with Valentine hearts and anti-nuclear decals.

Anti-nuclear activist JERRY RUBIN (not the former Yippie leader) says he began his fast Jan. 13 and has since lost 20 pounds but gained his goal of 2,000 signatures on letters addressed to the Nuclear Regulatory Commission in Washington, D.C. Rubin says the letters thank the N.R.C. for their recent decision to prevent the opening of the Byron plant in Illinois and appeal to them to prevent the opening of Diablo, demanding more hearings on quality assurance and construction be held.

Rubin says he dedicated his fast to the memory of KAREN SILKWOOD and will break it with part of a "Split Bananas, Not Atoms" solar salad that he and his wife MARISSA ROTHBERG will prepare for the occasion

The Children's Tree of Life was planted last April 22 at an Earth Day peace celebration and was the site where Rubin and Rothberg were married in a combined peace wedding and anti-nuclear rally last June 12.

Rubin began his fast to coincide with and support the Abalone Alliance coordinated People's Emergency Response Plan, a sustained action intended to provide a variety of non-violent activities for people to show opposition to Diablo Canyon.

In August, 1981 Rubin walked over 200 miles from Santa Monica to the plant location to participate in that years' non-violent blockade. More than 1900 protesters were arrested at the time.

The \$4.5 billion reactor is located in Avila Beach, CA., 2 1/2 miles from an active earthquake faultline. N.R.C. hearings begin Feb. 10 and a tentative date for the vote on low power testing is Feb. 17.
