On September 19, 1983, PGandE submitted an update of the tentative schedules for NUREG-0737, Supplement 1 items. Since that time, three scheduled activities have been completed. These are:

Completion of construction activities for the Emergency Operations Facility (EOF).	8.4	December 1983.
Functionality of Unit 1 EOF.	8.4	February 29, 1984.

Although PGandE has been working to meet the schedules provided in the September 19, 1983 submittal, additional work, not anticipated at the time of the September 19, 1983 submittal, has been necessary on Unit 1. Because available resources were committed to the completion of Unit 1, it has become necessary for PGandE to change the tentative completion dates for the Unit 2 Safety Parameter Display System (SPDS), EOF and TSC to prior to Unit 2 criticality. The EOF and TSC are functional except for the Unit 2 data
