Proposed Revisions to FSAR Update, Chapter 17

Dear Mr. Martin:

Enclosed is a revision to Chapter 17 of the Diablo Canyon Power Plant Final Safety Analysis Report (FSAR) Update. It replaces, in its entirety, the Chapter 17 submitted by PGandE letter DCL-84-308, dated September 21, 1984.

Pursuant to 10 CFR 50.54(a)(3), this submittal identifies all changes to the quality assurance program description of Chapter 17 (see Enclosure 1). Most of the changes made are editorial in nature. However, several changes in Enclosure 1 represent a clarification in wording which may appear to be a reduction in commitment; these changes are identified by a "50.54" next to the change bar in the margin. Five changes fall under this category and they are submitted as follows:

- 1. Table 17.2, Sheet 1 of 4 Indicate that alternate housekeeping zones will be utilized. See Enclosure 2 for justification.
- 2. Table 17.2, Sheet 3 of 4, and page 17.3-2 Indicate that immediate supervisors may be utilized to conduct design verification. See Enclosure 3 for justification.
- 3. Page 17.3-1 Delete quality control review of design drawings and specifications. See Enclosure 4 for justification.
- 4. Page 17.9-1 Delete calibration and fluid system flushing from the list of special processes. See Enclosure 5 for justification.
- 5. Page 17.12-1 Revise "possible" to "practical" as applied to the calibration standard accuracy requirements. See Enclosure 6 for justification.
