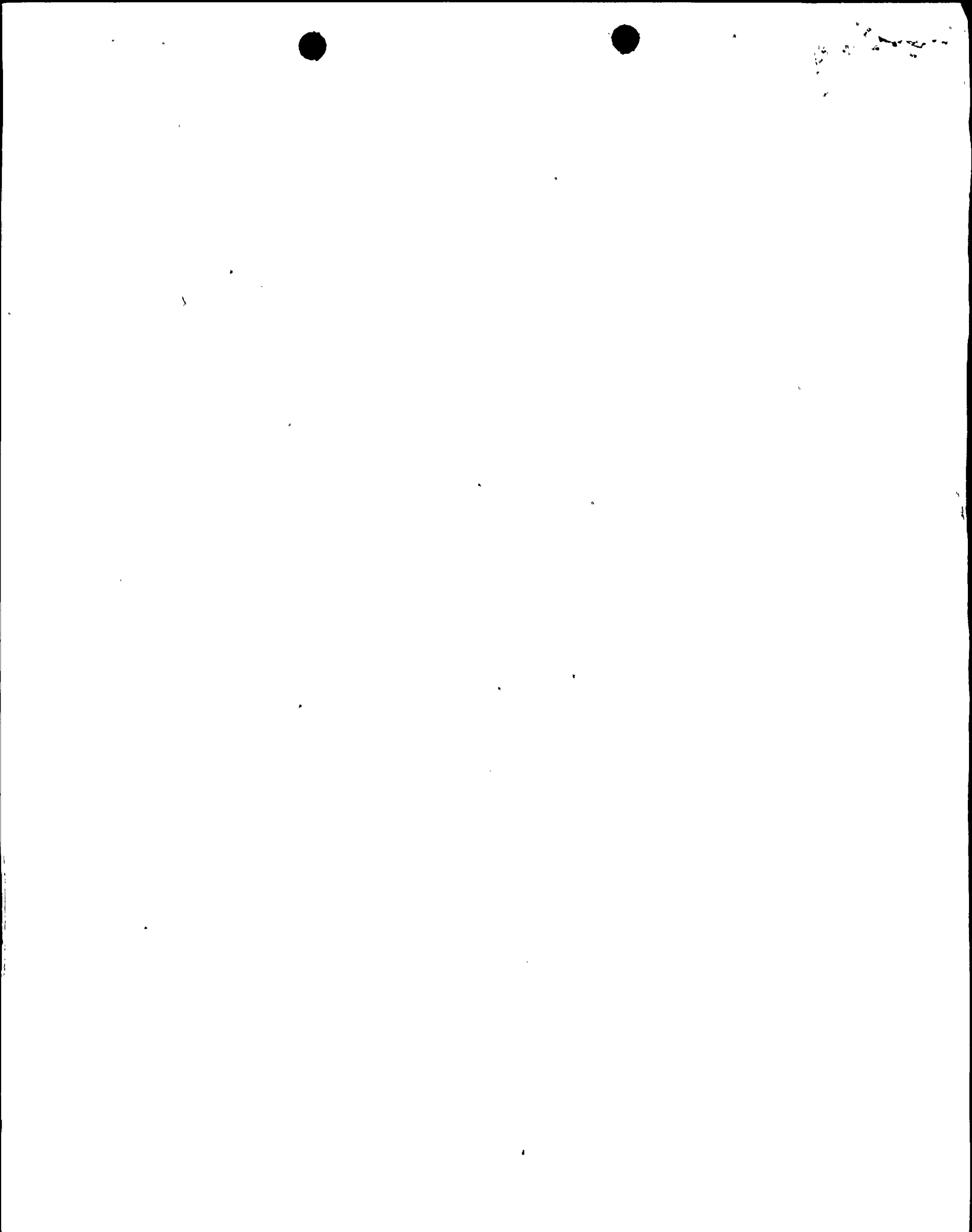

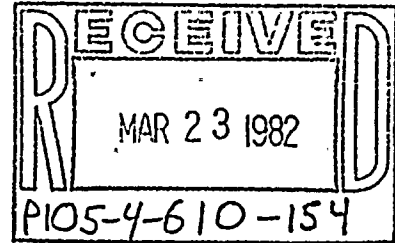

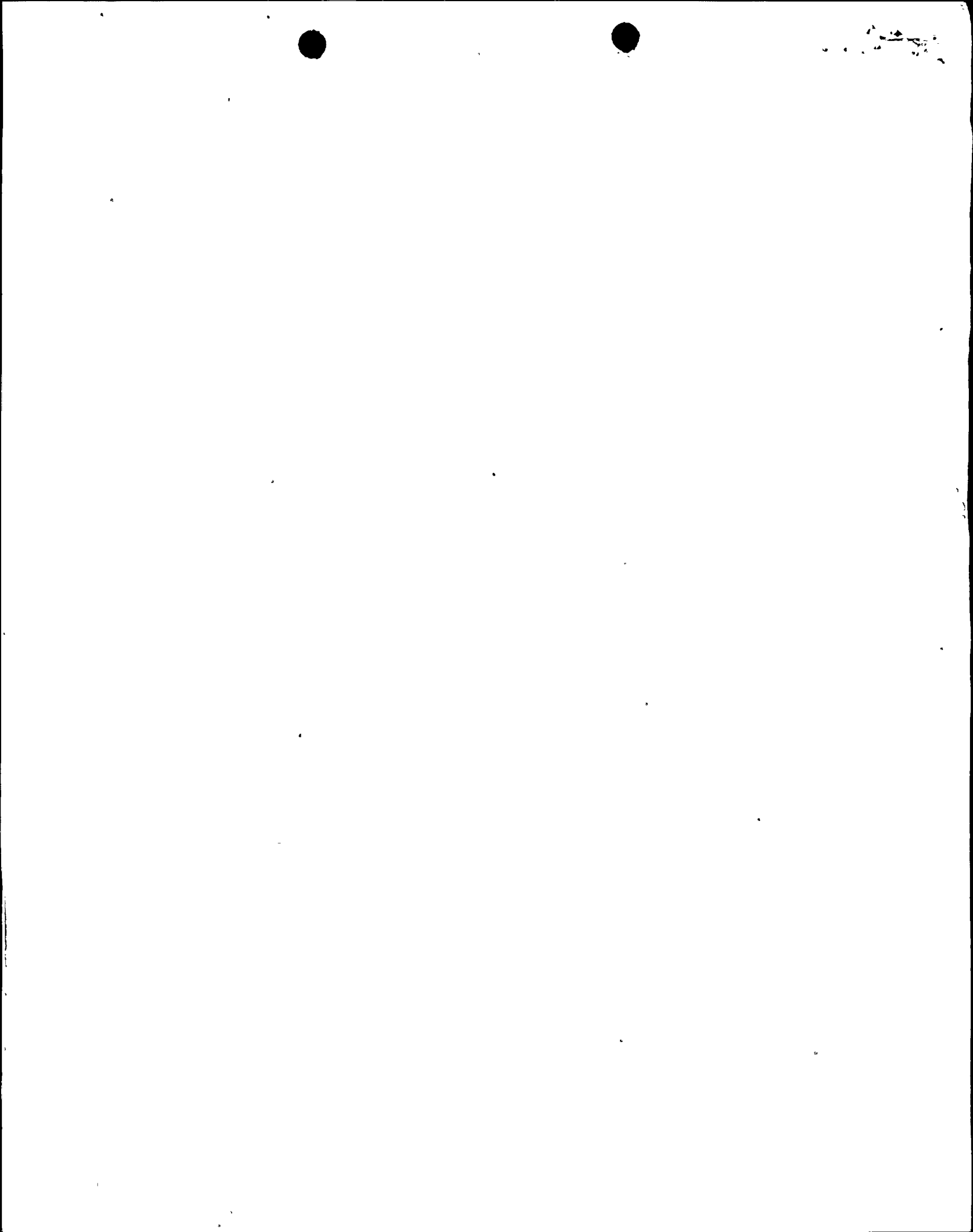
This report covers our activities through March 23, 1982, with regard to our independent Quality Assurance reviews of the Diablo Canyon Unit 1 Plant.

To summarize our activities to date, we have completed the following steps in our review of the quality assurance programs of PG&E and the six primary organizations performing seismic safety-related design work under subcontract to PG&E:

- (1) We have completed our reviews of PG&E's and the six design subcontractors' quality assurance program manuals and procedures.
- (2) We have completed the implementation audits of the six design subcontractors and PG&E. The Audit Reports were completed and forwarded as indicated below:

PG&E	-	March 8, 1982


- (3) Preparations were made during the last week, for the NRC meetings in Bethesda, Maryland, on March 25 and 26, 1982.
