SUBJECT: DIABLO CANYON - SSER 31: STAFF EVALUATION OF MISCELLANEOUS
MATTERS FOR UNIT 2 (BOARD NOTIFICATION NO. 85-051)

In accordance with NRC procedures for Board Notifications the enclosed Supplement No. 31 to the Diablo Canyon Safety Evaluation Report (SSER 31), dated April 1985, is provided for your information. SSER 31 presents the staff evaluation of those matters that needed to be appropriately resolved prior to a licensing decision. SSER 31 includes the basis for certain license conditions that are included in the Unit 2 low power operating license. The report also includes the staff evaluation of certain NUREG-0737 Items. While the report was specifically prepared in support of a Unit 2 licensing decision it also addresses matters with respect to Unit 1, as applicable.

The staff briefed the Commission on these matters in a meeting on April 23, 1985. There are no issues identified in the report that need further evaluation prior to low power operation of Diablo Canyon Unit 2.

By copy of this memorandum the Appeal Board and the parties to the Diablo Canyon proceeding are provided the same information.
