Dear Mr. Knighton:

Pursuant to your September 25, 1984, request for information regarding Unit 2 response to allegations identified in Supplemental Safety Evaluation Report (SSER) No. 26, PGandE submitted an allegation review program summary and status report on October 5, 1984 (DCL-84-323). Your September 25 letter also requested an additional status report on allegations by October 22, 1984. The following information documents the status of the Unit 2 allegation review as of October 19, 1984.

As of October 5, 1984, approximately 75% of the 581 NRC-resolved allegations had been reviewed for initial assessment by the PGandE Unit 2 Allegation Review Coordinator. As of October 19th, all 581 of these allegations have been reviewed for initial assessment by the Unit 2 Allegation Review Coordinator. As of October 5th, the review of 90% of the design-related allegations had been completed by cognizant design engineers. As of October 19th, the review of 95% of these allegations has been completed. As of October 5th, the non-design-related allegations were being reviewed by cognizant non-design personnel. As of October 19th, the review of 27% of these allegations has been completed.

PGandE intends to complete the allegation review of all 581 NRC-resolved allegations by November 5, 1984. At that time, a copy of the allegation review status matrix will be provided documenting the results of the review. If the allegation review is not complete by November 5th, PGandE will submit the status and schedule for completion at that time.
