SUBJECT: DIABLO CANYON ALLEGATION REVIEW BOARD MEETING

An Allegation Review Board, comprised of the below listed individuals, was convened on July 26, 1985, to examine and disposition the below listed items as follows:

OI Case No. Q5-83-019 (Allegation No. 0070): Possible False Statement by PG&E in Response to NRC Notice of Violation

Inquiry CLOSED without further action as OI found that the licensee and/or the contractor did not supply false information to the NRC.

OI Case No. Q5-83-011 (Allegation No. 0018): Falsification of Resumes

Investigation disclosed that RV staff had previously inspected the same allegation and concluded that the QC inspectors were qualified in accordance with commitments made by PG&E. Inquiry CLOSED.

OI Case No. Q5-83-017 (Allegation No. 0281--ATS No. RV-84-A-057): Intimidation of QC Inspectors

Alleger refused to provide specific information until such time as the union resolved his termination by PPP for excessive tardiness and never re-contracted OI:RV as requested. This inquiry is CLOSED due to lack of specific information.

OI Case No. Q5-83-018: (Allegation No. 0053--ATS No. RV-83-A-039): Falsification of Welding Examinations

OI interviewed 9 welders and examined welder qualification and certification records and determined that there was no apparent wrongdoing in matters over which the NRC exercises regulatory authority. This inquiry is CLOSED.

OI Case No. Q5-83-022: Defective Weld Reports

OI determined that this appeared to be a technical issue regarding the dispositioning of defective "weld reports" by H. P. Foley Co. Inspections by RV inspectors have not indicated this to be a problem (Allegation Nos. 0024 and 0066). Inquiry CLOSED.

OI Case No. Q5-84-003 (ATS No. OIRV-84-A-0006): Falsification of Radiograph Reports

The inquiry failed to develop any information to substantiate alleged's concerns. Inquiry CLOSED.

OI Case No. Q5-84-017: Alleged Sabotage and Other Wrongdoings

Alleger did not provide any firsthand information concerning problems. Interviews of pertinent witnesses failed to develop any information to substantiate the alleger's concerns. Inquiry CLOSED.


OI Case No. Q5-84-018: (Allegation No. 1477 ATS No. RV-84-A-043) Alleged Threats and Intimidation of QC Inspectors


The inquiry disclosed that the incident was reported to the PG&E hotline and subsequently; investigated by PG&E. The investigation determined that the actions of the Bechtel supervisor were not in accordance with acceptable construction practices. PG&E formally requested that the supervisor be removed from the job site and the request was honored by Bechtel. Also, the technical problems addressed by the allegers in their hotline complaint were resolved, as was the issue of a "Thermolag Request".

A review of the actions of PG&E resulted in the determination that no further action concerning the matter by OI:RV was appropriate. Inquiry CLOSED.

OI Case No. Q5-84-021: Alleged Welding and Quality Assurance Problems


OI supplied information to RV from two Cal Poly professors who had concerns regarding the quality of welding and other quality assurance problems related to them by their students who had worked at Diablo Canyon. This information was provided RV for follow-up by the technical staff. This Allegation No. 0993, currently under review by LLNL. Inquiry considered CLOSED. Allegation No. 0993 still OPEN.
