Enclosed are three (3) signed and thirty-seven (37) conformed copies of an application for amendment to Facility Operating License Nos. DPR-80 and DPR-82.

This License Amendment Request (LAR) proposes changes to the combined Units 1 and 2 Technical Specification 3/4.2.1 to implement relaxed axial offset control (RAOC) for Unit 1 after 8000 MWD/MTU burnup in Cycle 1. The proposed revision adds Technical Specification 3/4.2.1.1, "Axial Flux Difference," to include RAOC for Unit 1, and modifies the existing Technical Specification 3/4.2.1, "Axial Flux Difference," to be applicable to Unit 2 only.

Unit 1 is expected to reach 8000 MWD/MTU burnup by early November 1985. The requested license amendment should be made effective upon reaching that level of burnup, and PGandE will implement the added Technical Specification 3/4.2.1.1 for Unit 1 only after reaching 8000 MWD/MTU burnup for Unit 1. Existing Technical Specification 3/4.2.1 for Unit 2 will be renumbered at that time to 3/4.2.1.2. PGandE intends to perform a similar analysis to assess RAOC for Unit 2. When completed, PGandE will determine if a similar LAR for Unit 2 would be appropriate.

Pursuant to 10 CFR 170.12(C), an application fee of \$150 is enclosed.
