

PGandE letter DCL-85-261, dated August 1, 1985, noted that PGandE would provide a report on Generic Letter 83-28, Item 3.2 "Post-Maintenance Testing (All Other Safety-Related Components)," for Unit 1 by December 1, 1985.

To date, PGandE has developed a complete listing of all safety-related components, and completed review of vendor documents for post-maintenance testing requirements covering approximately 85% of all safety-related components.

PGandE's review of applicable vendor and engineering recommendations to ensure that appropriate test guidance is included in maintenance procedures or test procedures is continuing. PGandE currently plans to submit a report to the NRC by mid-March 1986.
