

Gentlemen:

This submittal presents PG&E's final status of the implementation of the revised FSAR, Chapter 17, approved by Region V on December 20, 1983, and submitted in the FSAR Update on September 21, 1984. A proposed modification to the FSAR Update, Chapter 17, was submitted for review on March 29, 1985 (PG&E letter DCL-85-133), and subsequently approved by Region V on August 21, 1985.

The enclosed final schedule updates the schedule provided in PG&E's letter dated May 5, 1986 (DCL-86-123). A schedule was initially provided as Enclosure 4 to PG&E letter dated June 29, 1984 (DCL-84-126), and was revised periodically as major milestones were reached. The revised Quality Assurance Manual Policy Sections and safety-related Quality Assurance Procedures (QAPs) were approved for issuance on March 26, 1986. The additional QAPs for the fire protection program, security program, radiation protection and radioactive materials control, emergency preparedness program, and nonradiological environmental protection were approved for issuance during August 1986, and the QAP for computer systems was approved for issuance on March 31, 1987. Full alignment now exists between Chapter 17, "Quality Assurance," of the FSAR Update, the quality assurance manual policy sections and procedures, and all affected departmental programmatic procedures. Thus, PG&E considers all changes in effect to reflect implementation of the enhanced guality assurance program.
