Gentlemen:

IE Bulletin No. 87-02 (Bulletin) directs licensees to submit a written response within 60 days (by January 15, 1988) on the receipt inspection requirements and internal controls for fasteners, and to independently determine, through testing, whether fasteners in stores at their facilities meet required mechanical and chemical specifications. PG&E selected fasteners for testing in accordance with the guidelines in the Bulletin, and the requested mechanical and chemical analyses of these fasteners were performed. However, additional time is required to perform additional sampling and testing and evaluate all of the test results.

As discussed with both the NRC Regional Inspector and the NRC Project Manager, PG&E is requesting additional time to provide a final report on the completed test program as soon as practicable but no later than the end of March 1988.
