This report is required by 10 CFR 50.36a(2) and Section 6.9.1.6 of the Diablo Canyon Technical Specifications.

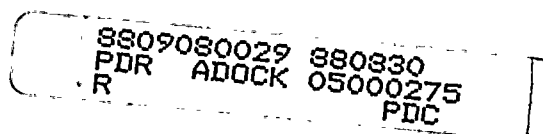
