NOTIFICATION OF SIGNIFICANT ENFORCEMENT ACTION

Licensee: Pacific Gas and Electric Company (EA 89-95)
Diablo Canyon
Docket Nos. 50-275 and 50-323

Subject: PROPOSED IMPOSITION OF CIVIL PENALTIES - \$75,000

This is to inform the Commission that a Notice of Violation and Proposed Imposition of Civil Penalties in the accumulative amount of Seventy-Five Thousand Dollars (\$75,000) will be issued on or about July 5, 1989 to Pacific Gas and Electric Company. This action is based on violations in two areas of concern. In the first, various violations involving engineering and design control were identified which resulted in, among other things, having less than the required number of auxiliary feedwater pumps. In the second, the licensee failed to take corrective actions for identified conditions adverse to quality. The escalation and mitigation factors were considered and for the first problem 50 percent mitigation of the base civil penalty was deemed appropriate for the licensee's corrective actions. In the case of the second problem mitigation for corrective actions was offset by escalation for past poor performance.

It should be noted that the licensee has not been specifically informed of the enforcement action. The schedule of issuance and notification is:

Telephone Notification of Licensee July 5, 1989

The State of California will be notified.

The licensee has thirty days from the date of the Notice in which to respond. Following NRC evaluation of the response, the civil penalty may be remitted, mitigated, or imposed by Order.
