Subject: Quality Assurance Program Description for Diablo Canyon

We have reviewed your letter dated December 5, 1989, to Mr. J. B. Martin from Mr. G. A. Maneatis requesting our concurrence in your selection of Mr. Sexton as Quality Assurance Manager. The request involves a change to one of your Quality Assurance program requirements, [i.e. FSAR page 17.1-6, dated September 1988, Revision 4, states in part: "At the time of .... assignment to the active position, the Manager, Quality Assurance, shall have six years experience in the field of quality assurance .... At least one of these six years of experience shall be nuclear power plant experience in the overall implementation of the QA Program. (This experience shall be obtained under the QA organization)."]

In that Mr. Sexton does not have one year of Quality Assurance experience gained within the QA organization, it appears that his selection would not be consistent with your QA program requirements. Thus, if you wish to appoint Mr. Sexton as Quality Assurance Manager, we would encourage you to submit a change to your Quality Assurance program, in accordance with 10 CFR 50.54a(3).

Upon receipt of your submittal, the NRC will review the acceptability of this change and so advise you of our determination.
