**EXAMINATION REPORT** 

During the period May 20-23, 1991, the NRC administered initial licensing examinations to five Reactor Operator candidates who had applied for licenses to operate your Diablo Canyon Nuclear Power Plant.

All of these candidates passed their examinations and were subsequently issued a license. However, the examiners identified one deficiency which is of particular concern:

Technical Specifications sent to the NRC for examination preparation and utilized in the simulator for operator training were found to be out of date. Your attention is called to this matter as Technical Specifications are an integral part of your licensing and operating documents and are to be maintained current with the correct revision.

This deficiency was discussed with the members of your staff identified in the enclosed examination report (Enclosure 1), during an exit meeting on May 23, 1991.

Your staff agreed to respond, in writing, to all of the NRC findings, detailed in the enclosed report, within 30 days of the date of this letter.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and Enclosure (1) will be placed in the NRC public document room.

The response requested by this letter is not subject to the clearance procedure of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
