NRC Requalification Program Evaluation and Subject: Examinations at Diablo Canyon Nuclear Power Plant

On May 7 - 17, 1991, the NRC administered requalification examinations to employees of your company holding Reactor Operator and Senior Reactor Operator licenses to operate your Diablo Canyon Nuclear Power Plant.

As a result of these examinations, seventeen Senior Reactor Operators and eleven Reactor Operators were found to meet the minimum qualification requirements for license renewal. This high pass rate on a challenging examination is noteworthy.

The facility requalification program was found to be satisfactory in accordance with Examiners Standard ES-601, "Administration of NRC Regualification Program Evaluations."

At the conclusion of the examinations on May 17, 1991, the examination process and preliminary findings were discussed with members of your staff as detailed in the enclosed report.

In accordance with 10 CFR 2.790(a), a copy of this letter and enclosure (1) and (2) will be placed in the NRC's Public Document Room. Enclosure (3) is Personal Privacy Information and will be withheld from public disclosure in accordance with 10 CFR 9.5(a)(6).
