SUBJECT: MANAGEMENT MEETING



We support the work performed on the Diablo Canyon Probabilistic Risk Assessment (PRA). We encourage you to monitor the efforts made to keep the PRA current with the plant. In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room.

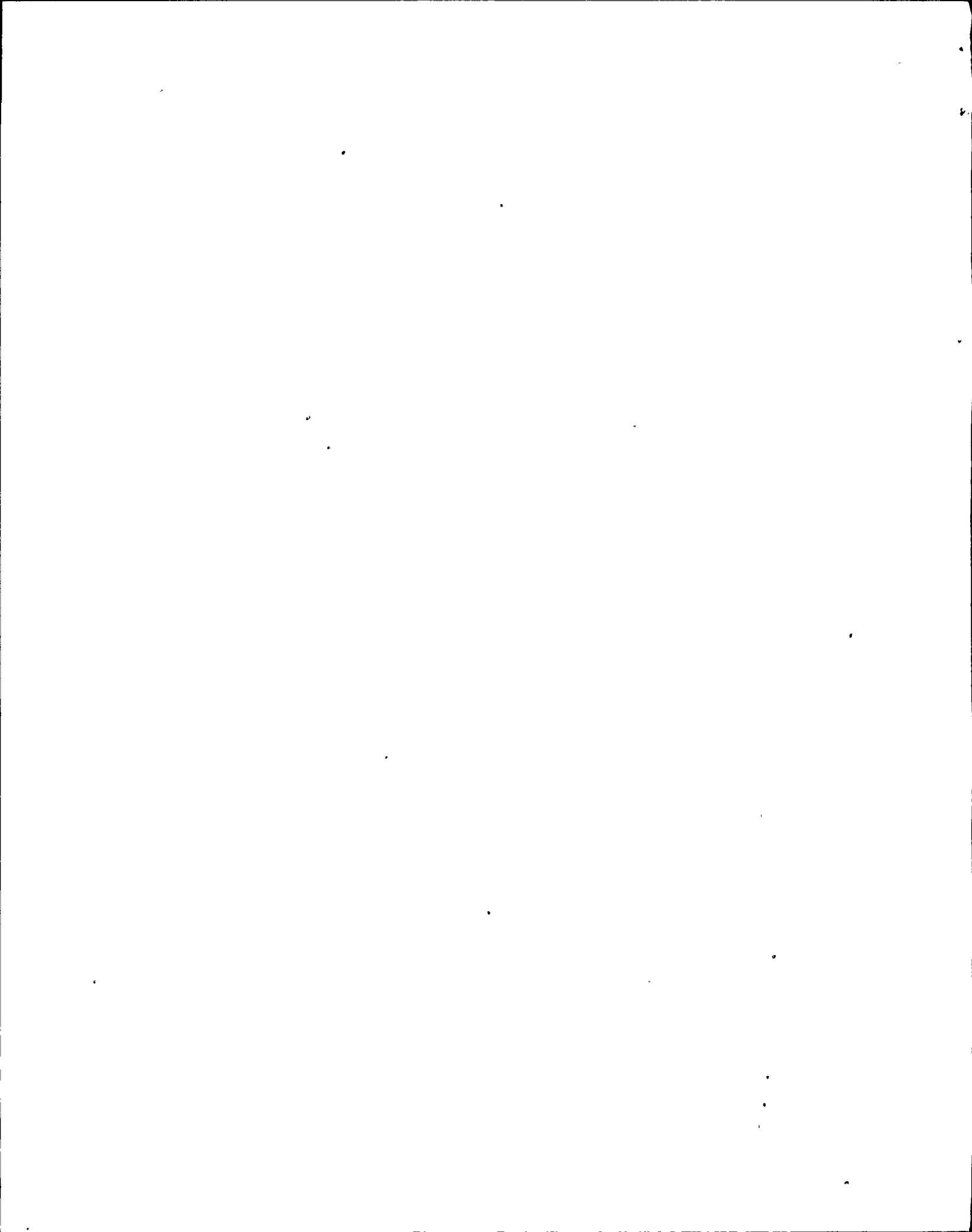
Your continued cooperation is appreciated. If you have any questions concerning this management meeting report, we will be pleased to discuss them with you.

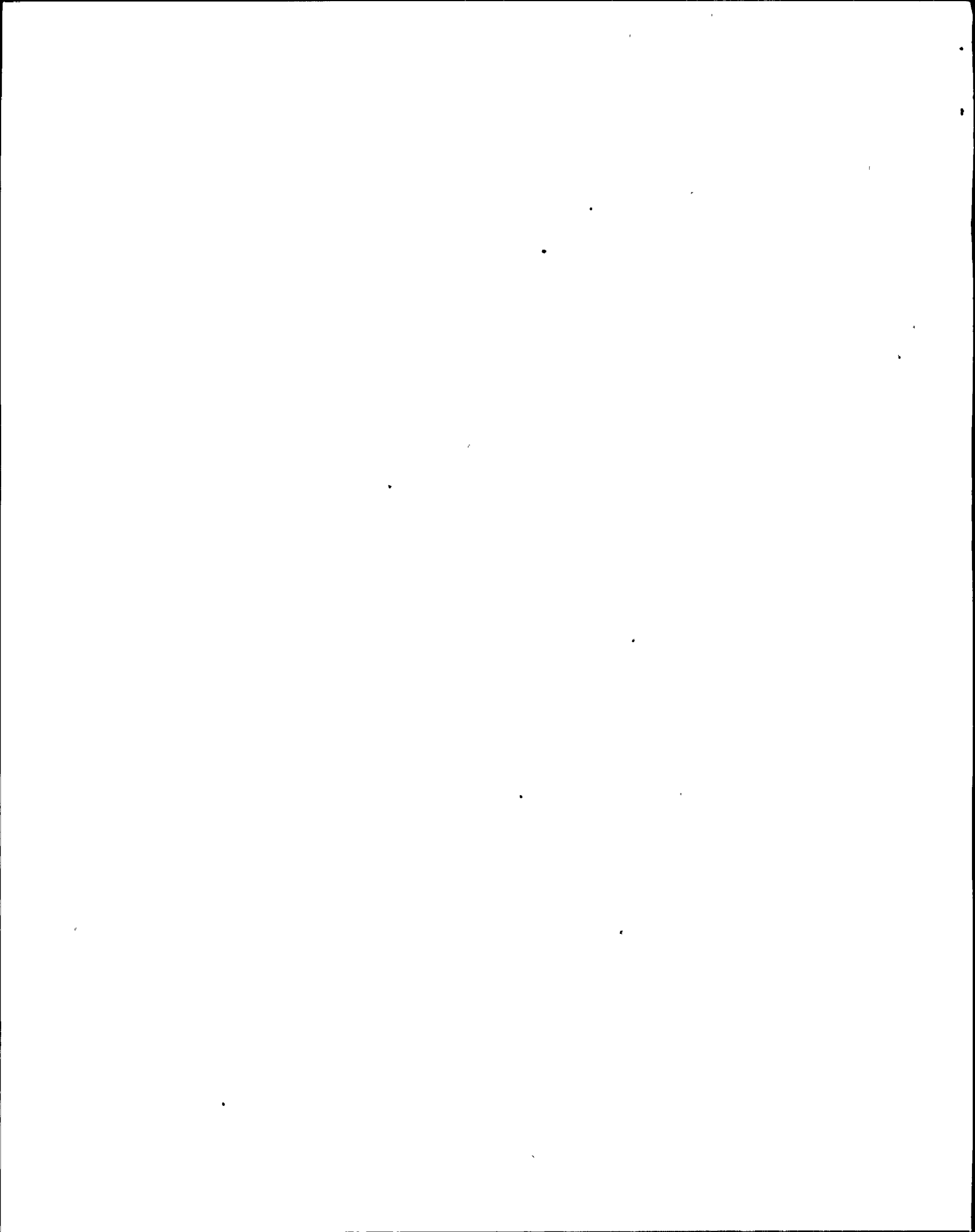
