Subject: Change in Schedule of the Initial Reactor Operator Licensing
Examinations

Dear Mr. Rueger:

In our December 28, 1992 letter, the NRC made arrangements with Diablo Canyon for the administration of initial licensing examinations at Diablo Canyon Units 1 and 2. In that letter, the initial written examinations were scheduled for May 24, 1993, and the operating examinations were scheduled for May 25 through June 2, 1993.

Further review by the Chief Examiner of the licensing examination schedule indicates a more economical use of time and personnel resources is provided by administering the written examinations on Friday, May 21, 1993. The operating examinations would be administered on May 24 through May 28, 1993. The NRC examination exit would be scheduled for May 28, 1993.

The Chief Examiner has discussed this change in schedule with Mr. J. Welsch of your staff, who agrees that the change in examination dates is acceptable.

In summary, initial written examinations will be given on Friday, May 21, 1993. The operating examinations will be given on May 24 through May 28, 1993. The NRC exit will be during the afternoon of May 28, 1993.
