Gentlemen:

Enclosed is an application for amendment to Facility Operating License Nos. DPR-80 and DPR-82 for Diablo Canyon Power Plant, Units 1 and 2, respectively. The enclosed license amendment request (LAR) proposes to change Technical Specification (TS) 3/4.3.2, "Engineered Safety Features Actuation System Instrumentation," to revise Table 3.3-3, functional unit 6.c.2), Start Turbine-Driven Pump, and Table 3.3-4, functional unit 4.e, Negative Steam Pressure Rate - High.

This LAR revises TS changes originally issued in License Amendments 84 and 83 for the Process Protection System Upgrade (Eagle 21). PG&E plans to begin installation of Eagle 21 equipment in March 1994 during the Unit 1 sixth refueling outage. The requested TS changes are required for Mode 3 operation following the Unit 1 sixth refueling outage. Therefore, PG&E requests that the NRC review of this LAR be assigned a high priority and the proposed changes be made effective immediately following issuance of the license amendment.
